4.1	<p>Registration of Atteridgeville People on the PSIF Dabatase:</p> <p>Chairperson highlighted that; in the last meeting, a team lead by Ms Karabo Hlabyago and officials from Necsa were to deal with an issue of registration of Atteridgeville people on the PSIF database. Once the proposal is complete, it should be presented in the PSIF meeting.</p> <p>Karabo responded on the issue of registration highlighting that in the last meeting it was proposed that the registration happens via putting an advert through newspapers (Kormorant and Tshwane Sun), Short Message Service (SMS) as well as Ward Councilors. About the issue of doing the registration via Councilors, according to Karabo, at least there must be an agreement with those Councilors and mentioned that in some areas, they call meetings which might cause a challenge. Karabo further mentioned that she did make proposal (which is somehow not reflecting on the minutes) and that was about embarking on a door-to-door campaign doing the registration because the majority of Atteridgeville people do not have access to technology.</p> <p>The chairperson advised Karabo to go work on the proposal and have it ready to be shared by members in order for them to understand the recommendation.</p>	Ms Hlabyago
4.2	<p>Progress on the potholes issue:</p> <p>Mr Bob Rathebe from Madibeng Municipality responded saying that three potholes were fixed but Mr Jakes Rikhotso from North West Provincial Disaster Management Centre (PDMC) was to still get more information on the actual route from Necsa. Mr Rathebe promised to make a follow up with Mr Rikhotso who could not attend the meeting.</p>	Mr Rathebe

4.3	<p>Issue of unclarified reports/proposal in the minutes:</p> <p>The member raised a concern about the lack of clarity in the minutes whereby a report is mentioned with no details on what it's about.</p> <p>Ms Nikelwa Tengimfene clarified that the Group CEO, Mr Phumzile Tshelane could not attend the previous meeting so, the presentation on Necsa Update was deferred to this meeting but the printed copies were given to members.</p> <p>Mr Phumzile Tshelane clarified the member's concern which was to give a brief details on what the report/proposal is about.</p> <p>The chairperson suggested that moving forward, if there's such information (report/proposal), it should be attached to the minutes.</p>	
4.4	<p>Necsa Communication Strategy on how to communicate to members of the community:</p> <p>The chairperson asked if Necsa has the presentation on how they going to communicate to the members of the community.</p> <p>Ms Tengimfene responded saying that the strategy is not ready for presentation as the draft is still undergoing an internal process of approval.</p> <p>Chairperson asked if the IT system has been sorted with regards to the SMS.</p> <p>Ms Princess Mthombeni added saying; on the issue of SMS there may have been a misunderstanding because as per the registration form that went out, the third option was for people to register via sending WhatsApp messages on her cellphone number. It may have happened that the member sent a WhatsApp message at the time where her cellphone was lost.</p> <p>The chairperson raised a concern about a single person being responsible for the registration. He further requested if Necsa could work on an alternative.</p> <p>The chairperson requested that in the Communication Strategy Presentation, Necsa must incorporate the information about the number of people that are in the database and also how often the database is updated.</p>	Ms Tengimfene
4.5	<p>Transport to PSIF Meetings for Atteridgeville members:</p> <p>Ms Tengimfene informed members that as per the recommendation from the previous meeting, the issue of transport was attended to and Atteridgeville members came with a Necsa bus to the meeting.</p>

5.1	<p>Necsa Update:</p> <p>Mr Phumzile Tshelane, Group CEO of Necsa gave feedback on the following topics:</p>

5.2	<ul style="list-style-type: none"> ▪ Nuclear Technology Schools of Specialisation ▪ National Science Week ▪ Eastern Cape Outreach ▪ Women's Day ▪ Status Update on NTP Radioisotopes ▪ IRP 2018 ▪ Media Briefing <p>.</p> <p><u>Discussions:</u></p> <p><u>Comment 1:</u> Mr Gaopalewe Santswere added clarifying that as per the current draft Intergrade Resource Plan (IRP), there will no longer be nuclear in 2035.</p> <p><u>Question 1:</u> Why is it taking so long to sort out the issue of NTP as it might be influencing people to speak bad about the nuclear industry?</p> <p><u>Question 2:</u> Member asked if the issue of NTP is not affecting the business as well as the patients who are relying on the nuclear medicines for treatment.</p> <p><u>Response for 1 & 2:</u> Mr Tshelane responded to the issue of NTP saying; it's a concern and agreed that we should make our facilities work for us. He further highlighted that there are plans in place.</p> <p><u>Question 3:</u> The member raised a concern about the issue of Schools of Specialisation project which was not articulated well. He suggested that Necsa should consider having a Necsa centre that can be accessible by the community which will be mainly responsible for giving people information about activities such as Schools of Specialisation. The member further pointed out that people including learners from other schools might want to be part of schools of specialisation in nuclear technology and as leaders of the community, they should be able to send people to a Necsa centre to get more information.</p> <p><u>Response for 3:</u> Mr Tshelane responded saying that the vision of Schools of Specialisations in nuclear technology emanates from a vision that was identified by the Gauteng Department of Education. Schools of townships have less children as they are bussed to previous "model C" schools. So to bring back the value of township schools, a decision was made to find curriculum schools in townships that can attract an investment from industries such as Necsa, Aviation, etc. to ensure our children access the right skills, in line with industry demands. He further alluded that even though this is a vision but it has to start somewhere small and the intention is not to stop here but to grow and hopefully open another school in the Free State province. Mr Tshelane described this plan as a "revolution" and believes that such starts with engagements with few individuals in the street corners.</p> <p><u>Question 4:</u></p>

5.3	<p>Member asked for information about the gas that was said to have been discovered from the Northern Cape?</p> <p><u>Response for 4:</u> Mr Tshelane responded saying; there is no gas in the Northern Cape, yet. There is gas in other countries but to prospect and access it they needed investment. The only way to access it is to buy it at a spot price.</p> <p><u>Question 5:</u> Member thanked the Group CEO for the IRP information and highlighted that many people lack knowledge and understanding of the subject. She further asked if there's ways to educate people about this IRP to make them understand it in order for them to be able to voice out their opinions.</p> <p><u>Response 5:</u> Mr Tshelane responded saying; Necsa reports to the Department of Energy which is responsible for electricity planning and it's not his place to mobilize communities against the DoE plan. It's not Necsa's role to mobilize communities, institutions or even Unions to oppose to the IRP.</p> <p><u>Community Service Feedback Update:</u></p> <p>Ms Mosa Rasweswe gave a presentation which outlined the following:</p> <ul style="list-style-type: none"> ▪ Safety Culture ▪ Statutory training ▪ NNR Emergency Exercise ▪ Internal SHEQ audits ▪ Community Services ▪ Public dose 	
5.4	<p><u>Discussions:</u></p> <p><u>Question 1::</u></p> <p>The member raised a concern about an issue of safety at the institution like Necsa particularly the behavior of those employees who are said to have disappeared during the emergency exercise. He further said the fact that employees of Necsa could not comply with safety precautions rises a concern to the surrounding communities. Lastly, the member asked about the solution to this and if Necsa plans to take action against those employees.</p> <p><u>Response 1:</u> Ms Rasweswe responded saying that the presentation was general information to encourage everyone about the importance of following the safety procedure and it did not mean there was an issue at Necsa. She further clarified that during the emergency exercise, the holding point was outside Necsa and one of the areas of improvements that have been identified is to block the road to the main Ellias Motsoaledi Street in the future when these exercises occur.</p> <p>Mr Tshelane added saying; the reason for emergency exercises is essentially to test the understanding of the content. He further said that these exercises</p>

	<p>are not about punishment but rather find an area of improvement and fix it going forward.</p> <p><u>Comment 1:</u> The member indicated that when writing a presentation/report, it should be able to provide clear details to members for them to be able to be the champions of Necsa when they leave the meeting.</p> <p><u>Question 2:</u> Previously the emergency alarm testing occurred on Mondays at about 12:00 but it has recently the alarm goes off on different times. Furthermore, people do not know if it's a testing or the real exercise and this create a concern as in future, the alarm might be ignored.</p> <p>Response 3: According to the requirement, emergency alarm testing scheduled time is 12:00 but sometimes it gets tested earlier or later than that time. The responsible department has been informed to stick to the normal time.</p> <p><u>Comment 2:</u> The chairperson commented suggesting that the communication strategy should incorporate the alarm response and emergency exercises announcements.</p> <p><u>Response 4:</u> Mosa responded saying; the draft communication strategy does include the response from the community as well as the messages that are going to be communicated.</p>
